2. Purchase of the new Brother GT-541 Digital Garment Printer must be made between January 1, 2010 and March 31, 2010 from an Authorized Reseller. Offer is not valid in conjunction with any other Brother offer.
3. See list below for non-Brother models which will be accepted as trade-in. This list will also be located on Brother's website, [www.brother.com](http://www.brother.com),
4. Customer will be charged full price for the Brother GT-541 Digital Garment Printer at time of purchase by the Authorized Reseller. A credit of \$ 5,000.00 which represents Brother's qualifying trade-in value will be applied to the customer's account when the trade-in Digital Garment Printer or Dye Sublimation Printer has been shipped by customer and received by Brother International Corporation at the address provided below. Trade in Digital Garment Printer or Dye Sublimation Printer must be received within 30 days from date of purchase of new Brother GT-541 digital garment printer for credit to be issued.

Customer shall be responsible for all costs associated with the shipment of the trade in Digital Garment Printer or Dye Sublimation Printer to Brother including but not limited to all packing costs and the cost to insure the trade in Digital Garment Printer or Dye Sublimation Printer for \$5,000. Customer shall be solely responsible for any lost shipments.
6. Brother distributors, dealers, resellers and their employees and internal Brother orders are ineligible.
